PROMINENT EXAMPLES INCLUDE JCIE'S GLOBAL HEALTH PROGRAM, WHICH EXPLORES THE ROLE OF THE U.S. AND JAPAN TO IMPROVE GLOBAL HEALTH AND THE CONNECTIONS BETWEEN HEALTH SECURITY AND OTHER KEY ISSUES, INCLUDING ITS WORK THROUGH THE FRIENDS OF THE GLOBAL FUND, JAPAN (FGFJ), AND JCIE'S EXPLORATION OF WAYS TO PROMOTE HEALTHY AND ACTIVE AGING IN ASIA.
